NOTIFICATION

No.E.256272/177.- In exercise of the powers conferred by section 20 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and in pursuance to the decision taken by the Governor of Assam pending finalization of the Service Rules to be framed in exercise of the powers conferred by the Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following Orders further to amend the Assam Directorate of Prosecution Establishment Officers' Service Orders, 2022, hereinafter referred to as the principal Orders, in the manner hereinafter appearing, namely:-

- Short title and commencement
1. (1) These Orders may be called the Assam Directorate of Prosecution Establishment Officers' Service (Amendment) Orders, 2025.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- Amendment of order 5
2. In the principal Orders, in order 5, in second line, for the word "of" appearing in between the word and figure "period" and "3 (three)" the word "not exceeding" shall be substituted and in third line, for the figure "60" appearing in between the words "age of " and "years", the figure "65" shall be substituted.
- Amendment of order 7
3. In the principal Orders, in order 7, for the existing Table, the following shall be substituted, namely:-

Sl. No.	Category	Eligibility
(i)	Director of Prosecution	having experience as an Advocate for not less than fifteen years or is or has been serving as a Sessions Judge
(ii)	Deputy Director of Prosecution	having experience as an Advocate for not less than fifteen years or is or has been serving as Sessions Judge

”

Amendment of order 10 4. In the principal Order, the words “The maximum age limit for direct recruitment to the post of Director of Prosecution and the post of Deputy Director of Prosecution may not exceed 60 years.” shall be deleted.

Omission of order 14 5. The order 14 shall be omitted.

Amendment of Order 15 6. In the principal Orders, for Order 15, the following shall be substituted, namely:–

“15. (1) The selection of the Director of Prosecution and Deputy Director of Prosecution shall be made through proper identification of candidates from a panel of 3 to 5 applicants, having qualifications as required under Order 7, by a Search Committee. The panel list of the selected candidates shall be submitted to the Appointing Authority and the Appointing Authority shall appoint the Director of Prosecution and Deputy Director of Prosecution out of the panel of names recommended by the Search Committee.

(2) The Search Committee shall consist of the following, members, namely:–

(i)	Advocate General, Assam	Chairman
(ii)	Chief Secretary, Assam or his nominee from the level of Additional Chief Secretary	Member Secretary
(iii)	Director General of Police, Assam	Member
(iv)	L.R-cum-Commissioner and Secretary, Judicial Department, Assam	Member

(3) When an appointment is to be made, the Appointing Authority may temporarily appoint a person having the qualifications as specified under order 7 initially for a period of four months which may be extended from time to time.”

Amendment of order 19 7. In the principal Orders, in Order 19, for the existing Table, the following shall be substituted, namely:–
