**ORDER**

**eCF No. 649834/353**

Whereas, vide Notification No. eCF-649834/350 dated 29/01/2026 issued by the Government in the Home (A) Department, Shri Dibakar Deka, Inspector (AB), was promoted to the rank of APS (Junior Grade) and posted as Assistant Commandant, 27<sup>th</sup>APBn., Khajuabeel, Udalguri;

And whereas, as per Rule 10 of the Assam Police Service Rules, 1966 (as amended), the minimum educational qualification prescribed for promotion from Inspector of Police to APS (Junior Grade) is a Bachelor's Degree from a recognized University;

And whereas, upon verification of records, it has been observed that Shri Dibakar Deka does not possess the minimum prescribed educational qualification of a Bachelor's Degree as required under the aforesaid Rules;

And whereas, the eligibility criteria prescribed under the statutory Service Rules are mandatory in nature, and any promotion granted in contravention of such Rules is liable to be set aside;

Now, therefore, after careful examination of the matter and in exercise of the powers conferred under Rule 16(b) of the Assam Police Service Rules, 1966 (as amended), the Government hereby cancels the promotion of Shri Dibakar Deka to APS (Junior Grade) vide Notification No. eCF-649834/350 dated 29/01/2026 with immediate effect.

Consequently, Shri Dibakar Deka shall stand reverted to his substantive rank of Inspector of Police (AB) and placed under the disposal of Assam Police Headquarters with immediate effect.
