WHEREAS, in compliance of the directions at Para 140(1)(ii) read with Para 140(1)(vii) passed by the Hon'ble Gauhati High Court dated 20/06/2025 in W.A. 59/2023 (Kamal Debnath – Vs- State of Assam) and other linked cases, the Governor of Assam is pleased to withdraw the Govt. Order of discharging Shri Dilip Kumar Kalita, from Assam Police Service vide Notification No.HMA.924/2017/26 dated 27/07/2018;


