WHEREAS, in compliance of the directions at Para 140(1)(ii) read with Para 140(1)(vii) passed by the Hon'ble Gauhati High Court dated 20/06/2025 in W.A. 59/2023 (Kamal Debnath – Vs- State of Assam) and other linked cases, the Governor of Assam is pleased to withdraw the Govt. Order of discharging Shri Hemanta Saikia, from Assam Police Service vide Notification No.HMA.924/2017/28 dated 27/07/2018;

AND WHEREAS, as directed by the Hon'ble Gauhati High Court, the case of Shri Hemanta Saikia, who was on probation in Assam Police Service at the time of discharge vide Notification No.HMA.924/2017/28 dated 27/07/2018, is considered and upon consideration he is not found fit for confirmation and being a member of the Assam Police Service;

NOW THEREFORE, the Governor of Assam, in exercise of the powers conferred under Rule 16 (b) of the Assam Police Service Rules, 1966, is pleased to discharge Shri Hemanta Saikia, APS (Probationer) from service with effect from 27/07/2018 that is the date of discharge given vide No.HMA.924/2017/28, which stands substituted as directed by the Hon'ble Gauhati High Court.


