WHEREAS, in compliance of the directions at Para 140(1)(ii) read with Para 140(1)(vii) passed by the Hon'ble Gauhati High Court dated 20/06/2025 in W.A. 59/2023 (Kamal Debnath – Vs- State of Assam) and other linked cases, the Governor of Assam is pleased to withdraw the Govt. Order of discharging Smti. Sabbira Imran, from Assam Police Service vide Notification No.HMA.924/2017/25 dated 27/07/2018;

AND WHEREAS, as directed by the Hon'ble Gauhati High Court, the case of Smti.
