- ii) Document showing Date of Enrolment as an Advocate of the Bar Council.
- iii) Matriculation/ 10th Standard/ HSLC Admit Card/ Pass Certificate issued by Central/ State Board, having clear indication of the Date of Birth.
- iv) Pass Certificates and Mark sheets of all examinations from Matriculation/10th Standard/HSLC onwards up to Graduation and Bachelor of Law (LLB).
- v) Caste Certificate
- vi) Disability certificate
- vii) Identity proof (PAN/Aadhaar/Driving license/Passport etc).
