No. HMA-19015/9/2019-Political(A)/74:: Whereas, the Government of Assam in exercise of powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act 28 of 1958) had declared the areas covering 8 (Eight) districts viz. (1) Tinsukia (2) Dibrugarh (3) Charaideo (4) Sivasagar (5) Jorhat (6) Golaghat (7) Karbi Anglong (8) Dima Hasao of the State of Assam as "Disturbed Area" vide notification No. HMA-19015/9/2019-Political(A)/Pt.(1)/47, dated 23/03/2022 with effect from 01/04/2023 for a further period of 6 (six) months;

Whereas, Assam Police Headquarter and ADGP (Special Branch), Assam have submitted reports showing the improvement of Law and Order situation in the state of Assam

And whereas, Govt. of Assam in Home & Political Department submitted a proposal accordingly to Govt. of India, Ministry of Home Affairs vide this Department's letter dated 12/09/2023.

And whereas, Govt. of India, Ministry of Home Affairs after careful consideration of the proposal intimated Govt. of Assam vide letter No. 11011/51/2015-NE.V dated 26/09/2023 that the declaration of "Disturbed Area" may be removed from four (4) districts of Assam, namely Jorhat, Dima Hasao, Karbi Anglong and Golaghat for next six (6) months w.e.f 01/10/2023.

Now, therefore, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No. 19015/9/2019-Political(A)/Pt.(1)/47, dated 23/03/2022, the Governor of Assam is pleased to declare the areas covering 4 (Four) districts viz. (1) Tinsukia (2) Dibrugarh (3) Charaideo (4) Sivasagar of the State of Assam as "Disturbed Area" for a further period of 6 (six) months w.e.f. 01/10/2023, unless withdrawn earlier.
