No. HMA. 03/2023: - In exercise of the powers conferred by the proviso to section 115 of the Assam Police Act, 2007 (Assam Act No. XX of 2007), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Police Manual hereinafter referred to as the Manual, namely:-

Short title and commencement

- : 1. (a) These rules may be called Assam Police Manual (Amendment) Rules, 2023
 - (b) They shall come into force on the date of their publication in the Official Gazette

Amendment of rule 73

2. In the Manual, in Part-III, in rule 73, in second paragraph, at the beginning of the first line, between the word 'The' and ':' appearing in the second line, the following shall be substituted, namely:-

"Commissioner of Police in case of Police Commissionerate, Guwahati / The Senior Superintendent of Police / The Superintendent of Police in a district is competent to order the transfer and posting of an Inspector of Police within the district"

Amendment of rule 75

3. In the Manual, in Part-III, in rule 75, in sub-rule (A) the whole sentence shall be *substituted* by the following, namely:-

"Transfers of Inspectors from one district to another district are made by the Inspector General of Police and within the same district are made by The Commissioner of Police in case of Police Commissionerate, Guwahati / The Senior Superintendent of Police / The Superintendent of Police in a district."
