**OFFICE MEMORANDUM**

To uplift the morale and also in recognition of selfless service of police personnel who display exemplary courage and valour and in the process sustain permanent injuries (Bomb or Bullet injury) in the line of official duty due to which such personnel are unable to carryout strenuous physical activities and also to ensure that such police personnel are not deprived of their legitimate rights of the service progression and after careful consideration of Rule 16 (i), 37, 39, 40, 41 and 41-A of Assam Police Manual Part-III, the Governor of Assam is pleased to exempt such injured Police Personnel (Non-gazetted) from undergoing mandatory Pre-Promotion Cadre Course (PPCC) for consideration for promotion to the next higher rank subject to observance of the following procedures :

- 1) This will be restricted only for those who get permanently injured in the line of official duty.
- 2) The Director General of Police, Assam shall constitute a Committee comprising of such officers as he may deem fit for the purpose of selecting the eligible injured Police personnel (Non-gazetted) for exemption from attending and successfully completing the Pre-Promotion Cadre Course (PPCC). A representative from GMCH shall be included as Member of such committee.
- 3) As recommended by the Committee so constituted, the Director General of Police, Assam is vested with the power and may at his discretion exempt such injured Police personnel from attending and successfully completing the Pre-Promotion Cadre Course (PPCC).
- 4) After being exempted from attending and successfully completing the Pre-Promotion Cadre Course (PPCC), such Police personnel may be promoted to the next higher rank subject to fulfilment of requisite length of service in Assam Police as per existing rule.

This order may be implemented with retrospective effect to include all such injured Police personnel who fall in the category as stated above and who have been deprived of promotion to the next higher rank due to non-completion of Pre-Promotion Cadre Course (PPCC).

This O.M. has the approval of the Hon'ble Cabinet dated 23/01/2023.
