Sub : Creation of Special Task Force (STF) in Assam.

Sir,

I am directed to convey the sanction of the Governor of Assam to the establishment of the Special Task Force and subject to availability of fund under appropriate head of account in the budget, 2008-2009 to the creation of 126 (one hundred twenty six) numbers of posts of different categories as detailed below for a period up to 28.2.2009 with effect from the date of sanction. Risk Allowance to each of the categories of the Police personnel appointed in the Special Task Force as indicated against each below is also sanctioned.

In addition to the 20 (twenty) posts of Sub-Inspector, 3 (three) posts of Sub-Inspector in the SOU shall be transferred to the STF with prior approval of the Government.

Sanction of Risk Allowance to the Inspector General of Police incharge of STF is also accorded at the rate of Rs. 2000/- per month provided drawal of such allowance is admissible in addition to the pay and allowances as per provisions of the relevant IPS Rules.

The above sanction is made subject to the following conditions :

Handwritten notes and signatures on the left side of the page, including a signature and the date 16/7.

Handwritten signature and date 16/7/08.

The above mentioned posts shall be filled up within 31.07.2008 failing which the posts shall stand abolished.

The man power of both the STF and SOU will be reviewed on yearly basis.

3. On winding up of the STF and SOU the posts under these Organisations shall stand abolished and the man power will be absorbed against vacant posts existing at that time.

4. The APIQ shall move Government for re-imbursment of the cost of establishment of the STF and also for re-imbursment of the recurring expenditure on the STF.

The Sanction issues with the concurrence of Finance (EC-II) Department as conveyed vide their U.O. No. FEC(II)437/08, dtd. 03.06.2008 and approval of Finance (SIU) Department vide their U.O. No. FSI.156/2008, dtd 22.05.2008.
