Sub: Creation of (Home) ex-cadre post of Additional Superintendent of  
Police (Security).

I am directed to convey the sanction of the Governor of Assam to the creation of (Home) ex-cadre post of Additional Superintendent of Police (Security) in the rank of APS Sr. Grade-II to be located at Dulhajan in the Scale of Pay as per ROP, 2010, for the period upto 28.02.2015 w.e.f. the date of issue of sanction.

This is further subject to the following conditions:-

- (1) The Headquarter of the officer will be Dulhajan in the district of Dibrugarh. This post is within the prescribed limit of SDR.
- (2) The officer will be In-charge of security and law & order related issues concerning the Oil Sector in the Districts of Sivasagar, Dibrugarh and Tinsukia under the command and control of DIGP (E&K) Assam, Jorhat. In respect of the matters connected with any of the above 3 (three) Districts he will report to the concerned Superintendent of Police for assistance.
- (3) Expenditure incurred for this post will be re-imbursed by Oil India Ltd.
- (4) Staff, accommodation and other logistics support required by the officer for proper functioning will be provided by the Oil India Ltd. authorities.

The expenditure is debitable under the Head of Account "2055-Police-109, District Police -0145 Dist. Police Proper 01- Salaries Non-Plan (General)" in the budget for the current financial year 2014-15.

This issues with the concurrence of Finance (EC-II) Department vide their U.O. No. FEC(II)725/2014 dated 16.06.2014 and the Government have no objection to the filling up the aforementioned newly created post during the current financial year as per approval accorded by Finance (SIU) Department vide their U.O. No. FSI-344/2014, dated 20.05.2014.
