- 1) The Director General & Inspector General of Police ,Assam,Ulubari, Guwahati-7 for information and necessary action . He is requested to initiate actions for reimbursement of the cost of raising 1 (one) AP(IR) Bn from Govt. of India at the earliest opportunity. He will also make a detail review of the position of about 5000 trained Assam Police personnel deployed for escort, pilot, house guard and PSO duties for reduction from such duties so that the balance can be utilized for normal law and order maintenance and C.I. duties . He will also make every effort to deploy the I.R.Bn for Industrial Security duties with CPUs like ONGC, etc. or lend to other State Govts. and Central Govt. against payment when the services of I.R Bn, are not required for law and order of C.I duties within the State . He will further make a realistic assessment of the State Police man power requirement with reference to the ratio of Police personnel to total population of the States. Because of difficult terrain , etc the required ratio of Assam may even be higher than the all India average . He will come with relevant statistics on Police population ratio for some comparable states like Bihar, Chhatisgarh, Jammu & Kashmir etc. as well as the average for the Country as a whole, before moving Govt. for any further creation of posts or filling up of posts.


