**No. HMA(APS)1444/41** : Whereas, a report of the Superintendent of Police, Jorhat vide Memo No. JHT/V/2/2020/2098 dated 16/06/2020 as forwarded by the District Magistrate, Jorhat vide No.JMJ.25/2020/5 dated 17/06/2020 on the incident relating to the death of Shri Jayanta Borah allegedly in police custody, has been received;

Whereas, the deceased Shri Jayanta Borah, S/o Mrs. Lila Borah, Vill- Block No.5, Kakodonga Habi Gaon, PS-Borholla, Dist.-Jorhat had died allegedly in police custody;

Whereas, there has been gross negligence of duty by Shri Amit Kumar Hojai, APS, Sub-Divisional Police Officer, Titabor in the above incident;

Now, therefore, the Governor of Assam is satisfied that it is necessary and in the interest of public service to place Shri Amit Kumar Hojai, APS, Sub-Divisional Police Officer, Titabor, under suspension with effect from 18/06/2020 pending drawal of departmental proceedings.

Accordingly, the Governor of Assam is pleased to place Shri Amit Kumar Hojai, APS, Sub-Divisional Police Officer, Titabor, under suspension under Rule 6 (1) of the Assam Services (Discipline & Appeal) Rules, 1964 with effect from 18/06/2020.

Shri Amit Kumar Hojai, APS is allowed to draw subsistence allowances as admissible under provision of Rule 53(ii) (a) of the FRs and SRs subject to production of non-employment certificate under sub Rule (2) of F.R.53. During the period of suspension, his Headquarters will be o/o the Superintendent of Police, Jorhat.
