1. The Directorate of Vigilance & Anti-Corruption, Assam is hereby empowered to handle cases and enquiries that were previously investigated by BI (EO), Assam under the existing legal provisions.
2. All cases related to economic offences pending with the BI (EO), Assam, will come under the purview of the Directorate of Vigilance & Anti-Corruption, Assam.
3. Any functions that are not specifically assigned to any Department will fall under the purview of Directorate of Vigilance & Anti-Corruption, Assam, for allocation to relevant police units, following due process of law.

This notification comes into effect immediately.
