**Instructions to the candidates:**

- 1 The candidates are advised to download the Call Letter sent to their respective email ID and bring the same on the day of viva-voce.
- 2 Every candidate shall bring appropriate identity proof/ document to enable the Authorities to verify the identity of the candidate with the Call Letter etc. e.g. Aadhaar Card, Driving License,

Passport etc.

- 3 Any book, paper, cell phone, calculator or any electronic gadget or objectionable materials are not allowed in the Interview Hall. Candidates are allowed to bring only Call Letter, ball-point pen, Photo Identity Cards inside/ into the interview Hall. There will be provision for depositing Mobile Phone/ Electronic items outside the interview Hall.
- 4 Candidates are instructed to bring **all the original documents (Admit Card, Mark sheets, Pass Certificate etc.)** pertaining to educational qualification from HSLC onwards up to Graduation and L.L.B. for verification.
- 5 **Candidates are instructed to bring PRC/Caste Certificates / Ex-servicemen Certificate/ Disability Certificate issued by the competent authority.**
- 6 **Every candidate shall be required to produce before the Selection Board at least 1 (one) copy of any application/ petition/ appeal etc. drafted by the candidate themselves and filed and registered before a Court of Law in any criminal proceeding.**
- 7 **Every candidate shall be required to produce before the Selection Board 4 (four) copies of any order/ judgment passed by a Court of Law in any criminal proceeding in which the candidate himself/ herself appeared, conducted and argued the matter.**
- 8 Any discrepancy found in the Call Letter, including the complaint of any candidate not receiving Call Letter through email may be intimated to the Department at the following email address: [departmenthomea@gmail.com](mailto:departmenthomea@gmail.com)
- 9 The candidates are advised to reach the venue of interview prior to the Reporting Time.
- 10 Any candidate found using unfair means or violating the above or any of the **proficiency-cum-skill test/viva-voce** rules shall be disqualified and action taken as per norms.
- 11 **Mere issue of Call letter for the interview will not imply acceptance of candidature or selection of the post.**
- 12 **In case, it is found at any point of time in future during the process of selection or even after appointment that a candidate was not eligible as per prescribed qualification, experience etc. which could not be found at the time of selection due to whatever circumstances, his /her candidature /appointment shall be liable to be cancelled/terminated as the case may be.**
- 13 In case, a candidate has not received the Call Letter through email, he/she may collect a copy of the same from the Help Desk of the venue of viva-voce (proficiency-cum-skill test) on the day of viva-voce.
