ORDERS BY THE GOVERNOR

NOTIFICATION

No.eCF. 552949/596 :- In exercise of the powers conferred by the proviso to sub-section (1) of section 115 of Assam Police Act, 2007 (Assam Act No. XX of 2007), the Governor of Assam is hereby pleased to make the following rules further to amend Part-III of the Assam Police Manual, in the manner hereinafter appearing, namely:-

Short title and commencement

1. (1) These rules may be called Assam Police Manual (Amendment) Rules, 2025.
- (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule16

2. In the principal Manual, in Part-III, in rule 16, in sub-rule (i), in the second paragraph, for the words "A constable shall not be allowed to seat for the departmental examination for promotion to the post of Assistant Sub-Inspector of Police unless he has completed 5 (five) years of continuous service, out of which 3 (three) years of service must have been rendered in the Unarmed Branch, as on the date of Notice of the Examination, provided he is otherwise eligible, after the completion of the Basic Training in the Training School" the following shall be substituted, namely:-

"A constable who has completed 5 (five) years of continuous service either in the Armed Branch or Unarmed Branch and has also completed Basic Training in the Training School on the date of notice of the Departmental examination shall be eligible to appear in the examination for promotion to the rank of Assistant Sub-Inspector of Police (UB) provided, the constable possesses the minimum educational qualification of Higher Secondary (HSSLC) or equivalent examination."
