Consequent upon appointment of Shri Ranjit Kr. Pachnanda, IPS (Retd.) as Security Adviser to Chief Minister, Assam in the rank and status of Minister of State, Govt. of Assam, vide Govt. Notification No. HMA.13/2019/13 dated 28<sup>th</sup> January, 2019, the following terms and condition of his appointment are hereby laid :

1. The appointment shall be for a tenure of 1 (one) year w.e.f. 17/01/2019 with authorization to the Hon'ble Chief Minister, Assam to extend it by another year.
2. The rank and status of the Security Adviser to the Hon'ble Chief Minister, Assam shall be of the rank and status of Minister of State, Govt. of Assam.
3. The incumbent shall be entitled the Honorarium of an amount equivalent to last salary drawn minus present monthly pension.
4. Matters related to payment of Honorarium and other reimbursement of expenses of travelling expenses, travelling allowance as admissible etc. shall be processed by the CM's Secretariat.
5. The incumbent is entitled to vehicle, security, accommodation etc. to be provided by DGP, Assam.


