SHOW-CAUSE NOTICE U/S 4(2) OF THE UNLAWFUL ACTIVITIES  
(PREVENTION) ACT**

WHEREAS the Central Government in exercise of the powers conferred by the sub-section (1) of Section 3 of the Unlawful Activities (Prevention) Act, 1967 (hereinafter referred to as the "the Act") has declared the National Democratic Front of Bodoland as Unlawful Association, vide notification No. S.O. 4255 dated 23<sup>rd</sup> November, 2019 [published in the Gazette of India Extraordinary Part-II Section 3, Sub-section (ii)].

AND WHEREAS by the Gazette Notification No. S.O. 4577 (E) dated 20<sup>th</sup> December, 2019 [published in the Gazette of India Extraordinary Part-II Section 3, Sub-section (ii)], in exercise of the powers under Section 5(1) of the Act, the Central Government has constituted the Unlawful Activities (Prevention) Tribunal comprising Hon'ble Mr. Justice Prasanta Kumar Deka, Judge, Gauhati High Court, for adjudicating whether or not there is sufficient cause for declaring the National Democratic Front of Bodoland as unlawful association as required by section (1) of Section 4 of the Unlawful Activities (Prevention) Act, 1967.

NOW THEREFORE, a notice is hereby given to you under sub-section (2) of Section 4 of the Act and you are hereby called upon to show cause in writing within 30 days from the date of service of this notice as to why your association should not be

declared as unlawful and why order should not be made confirming the declaration made in the above mentioned Notification.

The objections/reply/written statement, if any, may be filed/delivered within the statutory period of 30 days from the service, to the undersigned at his office chamber of Joint Registrar (Vigilance), Registry of Gauhati High Court, New Block, 2<sup>nd</sup> Floor, Guwahati-1. In case objections/reply/written statements and documents are in regional language, their English Translation be also attached.

You are required to appear before the Tribunal on **02.05.2020** at 10:30 AM, which is situated in AAI Building (No.1), Flat No.8, 3<sup>rd</sup> Floor, Magistrate Colony (Near Guwahati Club Stadium Fly-Over) Hedayatpur, Guwahati, Assam for further proceedings.

Appearance can also be caused through a duly authorised and instructed Counsel/ Advocate.
