NOTIFICATION

- iv. Officers mentioned above from Sl no 16 to 17 shall be placed below Shri Vivek Syiem (IPS:2015), the junior most promotee IPS officer of 2015 batch of Assam-Meghalaya Cadre and above Shri Subhrajyoti. Bora (IPS:2016), the senior most direct recruit IPS officer of 2016 batch of Assam-Meghalaya Cadre.
