In pursuance of the Assam Directorate of Prosecution Establishment Officers' Service Orders, 2022, issued vide Notification No. HMA-11/225/2022/63 dated 17/02/2023; applications are invited from the eligible candidates for recruitment to 1 (one) temporary post of Director of Prosecution and 3 (three) temporary posts of Deputy Director of Prosecution, in the Directorate of Prosecution, Assam. (ii) Pass Certificates and Mark sheets of all examinations from Matriculation/ 10<sup>th</sup> Standard/ HSLC onwards up to the level of qualifying examination.

(iii) Document showing Date of Enrolment, with a self declaration that after enrolment he/she has not left practice as Advocate and has not joined any other service/ profession/business. In case contrary facts to such claim, comes to fore subsequently, his/her candidature shall be rejected and may even lead to termination from service, if detected after joining service.

(iv) 2 (two) Passport size photographs.

## 12 Selection Criteria:

Direct recruitment to the posts of Director of Prosecution and Deputy Director of Prosecution shall be made by a Selection Committee by adopting the summery recruitment process through verification of documents and Personal Interview.

After the verification of documents the Selection Committee shall call such numbers of candidates for personal interview, as many can reach the level, prescribed by the Committee.

The total marks for Personal Interview will be

50 marks. While granting marks in the Personal Interview the Committee shall, interalia, also take note of the number of years practiced as Advocate, number of cases appeared before the Court, number of cases reported against his/ her name, etc. The percentage of marks awarded to each candidate at the Personal Interview shall be added to the percentage of marks obtained by him/ her in the qualifying examination (LL.B.). On the basis of the average of both, the Committee shall prepare a list of the candidates in order of merit.

If two or more candidates obtain equal marks in the average, the name of the candidate obtaining higher marks in the qualifying examination (LL.B.) shall be placed higher in the list and if both such candidates have obtained same marks in the qualifying examination (LL.B.) then, the one senior in age will be higher in position.

For the post of Director of Prosecution, the Selection Committee shall forward a panel of 3 (three) names in order of preference, from the merit list so prepared, to the appointing authority. The appointing authority will select one name from the panel of 3 (three) names and send the name so selected for the concurrence of the Hon'ble Chief Justice, Gauhati High Court.

For the posts of Deputy Director of Prosecution, the Selection Committee shall forward as many names as the number of vacancies notified in this advertisement, to the appointing authority.

13	Date, Time and Venue of Personal Interview:	Will be announced and intimated in due course of time.
14	Physical and Medical Standards:	The candidates should be in good healthmentally and physically and he shall be free from any physical disabilities due to which there is a possibility of hindrance to performing his duty efficiently. Persons with speech, hearing and sight impairedness are not eligible for appointment to the posts of Director of Prosecution and Deputy Director of Prosecution. Any candidate before being finally approved for the recruitment will be expected to pass the Medical Board Examination.
